Sub: Revision of cost norms for DDU-GKY projects-reg.

It is hereby stated that taking into consideration Ministry of Skill Development and Entrepreneurship (MSDE) notification on Common Norms for all Skill Development Schemes (CNN) implemented by Government of India vide Gazette Notification No. H-22011/2/2014-SDE-I, dated 15 July 2015 and decisions of Common Norms Committee (CNC) vide its meeting held on 11-12-2015 and 23-03-2016, the cost components of Deen Dayal Upadhyaya Grameen Kaushal Yojana (DDU-GKY) have been revised w.e.f 1.4.2016. The revised cost norms and DDU-GKY provisions (aligned with CNN) are given in Annexure I and Annexure II.

2. It is further stated that:

(i) All new project proposals under DDU-GKY (including Roshni and Himayat

projects) shall be submitted online as per revised cost norms only.

(ii) Where project proposals under DDU-GKY (including Roshni and Himayat projects) have been submitted online, applicants shall be allowed a one-time opportunity to revise the proposals as per revised cost norms at online project revision module available at http://ddugky.gov.in without any additional application fee. Applicants are advised to complete this by 21st May 2016. No modifications shall be allowed after 21st May 2016, and applicants may file a fresh project application after depositing application fees.

(iii) In case of ongoing DDU-GKY projects (including Himayat and Roshni), project cost revision shall be effective only for training batches which are underway on 1.4.2016 or commencing after 1.4.2016. Expenditure for all training batches which have completed training as on 31.3.2016 shall be accounted in terms of pre-revised DDU-GKY cost norms. The following process shall be used for revision of project costs for ongoing DDU-GKY projects (both YP and AP state

projects):

(a) Identification of total number of candidates in training batches in on-going DDU-GKY projects in which training has been completed by 31st March 2016 (for this purpose MRIGS data or the 'S' Series datasheet shall be used). Every PIA with an ongoing project shall enter training batch completion details (as on 31.3.2016), and project cost as per revised cost norms in the online application by 21st May 2016 (no extension in dates shall be allowed for applying for revision of project costs, and

funding for training batches shall not be allowed after 1.4.2016 in case project costs have not been revised).

(b) Average cost of training of per candidate for completed batches to be determined. The basis for calculating average cost shall be the total cost of project (pre-revised) as mentioned in project sanction order. An example is given in **Annexure III.**

(c) Based on the average cost determined, total allowable expenditure for

completed training batches shall be determined.

(d) The total allowable expenditure for completed training batches shall be deducted from the total project cost sanctioned to a PIA.

- (e) The residual project cost shall be the ceiling for revision of project target allowed (in number of candidates) as per revised DDU-GKY cost norms. All project targets shall be right-sized as per the residual project cost in terms of revised cost norms.
- (f) The revision application filed by PIAs shall be verified by respective CTSAs for YP States or SRLMs for AP states and placed before Project Sanctioning Authority for issue of revised sanctions.
- (g) Project sanctioning authority shall issue a revised sanction order.

Note: MoRD shall provide an online module for revision of on-going projects at http://ddugky.gov.in. Revision of projects shall be entertained only through this module.

- (iv) After revision of project cost, concerned SRLM/SSM shall revise the total cost of Action Plan on the basis of revised DDU-GKY cost norms and submit the revised costs to MoRD for approval by 31st May 2016.
- 3. It is also stated that henceforth a DDU-GKY project (including Roshni and Himayat) shall be sanctioned for a minimum tenure of 3 years. Accordingly, in all ongoing projects whose tenure is less than 3 years, PIA concerned shall be given a one-time opportunity till 21st May 2016 to revise the tenure of the project along with consequent changes in Prospective Project Work Schedule (PPWS) for the remaining tenure of the project. Any PIA who is interested to revise the project tenure may indicate the same while filing revision application for the project (as at sl. 2(iii)(a) above).
- 4. This notification shall suitably replace provision of DDU-GKY Guidelines where relevant. The notification is issued in terms of approval of Empowered Committee of NRLM. The order comes into effect from 1.4.2016.
